

MARCUS ALERT POLICY UPDATE

A policy change was implemented effective Dec. 13, 2024 regarding our Marcus Alerts. Please make note of two key areas: Marcus Level 3 and Marcus Level 4 which focus on how EMS and Law Enforcement will be dispatched and how they will respond to the call either by going to the scene or staging.

Marcus Level 3: Will be dispatched and be displayed on Active 911 as "EMS to Scene"-LE will stage

Marcus Level 4: Will be dispatched and will be displayed on Active 911 as "EMS stage" - LE will go to the scene.

We understand that policy changes can raise questions, so we encourage you to reach out if you need further clarification or have any concerns. We are committed to ensuring smooth transitions when things like this happen and we appreciate your understanding and cooperation.

• CSR Update:

Progress is being made on the CSR. All the hardware has arrived and is bring prepared to be placed in the units. We have received our DEA license, keeping us on track to meet our projected goal date of middle to end of January.

Recruitment & Retention

Our First Recruitment and Retention meeting was held on December 12th, where several great ideas were shared. We will be working on plans to implement a few of these ideas. If you are interested in joining the committee, please contact Captain Wilkerson for more details.

CAD Update

A review of Fire responses to CAD incident types was conducted early last month. Minot corrections are planned for January. Dispatch and the county GIS team are working on mile markers so that calls to the Blue Ridge Parkway can be dispatched more quickly. Unit-based dispatching has been implemented in the CAD test environment and testing is scheduled for QI of CY 2025.

Please help dispatch by remembering to mark your rescue squad units unstaffed if you complete a call and go off-duty. Please do not mark fire apparatus out of service unless the vehicle is inoperable.

Also, please let Fire Admin know if CAD recommends incorrect units. These are investigated quickly, although there are times we have to wait for a fix from Motorola. Thank you for your patience as we have worked through this new system.


Operations

Bedford County Truck School

The 8th Annual Bedford County Truck School brought 84 students and 40 instructors to our area. 





Operations

Call Data

Call data is an essential tool for analyzing the efficiency and responsiveness of both career staff and volunteer agencies. By visualizing call data, we can identify trends, response times, and areas for improvement. Below are graphs visualizing our call data for both rescue squads and fire departments.









As of October 1st there have been 10 HazMat related incidents across the county, These incidents have ranged from fuel leaks to explosions and even downed aircraft. As we move into the new year, BC Jessee would like to provide a couple of reminders:

* Any fuel leak greater than 5 gallons must be reported to the Department of Environmental Quality (DEQ). Any fuel leaks regardless of amount that end up in waterways (creeks, streams, storm drains, etc.) must be reported. The easiest way to accomplish this is to notify BC Jessee or the Fire Marshal's Office.

* With colder weather, an increase in propane usage can be anticipated. We have already seen several propane related incidents and will likely see more. Please keep in mind that when checking for Lower Explosive Limits (LEL) with a 4 or 6 gas detector, a correction factor must me applied to your reading. These are found on the quick reference tags attached to all monitors and are specific to that monitor. For Example: Your Qrae3 four gas monitor is reading 10% LEL at a propane incident and the correction factor is 1.6, the corrected LEL reading is 16% and not 10%. Remembering this can prevent us from unnecessarily putting ourselves in a hazardous situation.

Check station for:

- Ice Melt
- Snow shovel

When doing your truck checks, look under the units as the drop chains. If something looks odd (bent, broken, etc.) report it.

Starting at 8am, lasting until approximately noon, Bob Page will present "Slap The Cap", all about capnography.


After breaking for lunch, Bob Page will present High Performance Ventilation starting at 1pm until approximately 5pm.
